Purpose

The <u>Health</u> of <u>Children and Measures</u> of <u>Parental Support</u> (Health ChAMPS) Survey was developed by Public Health Ontario (PHO) for the purpose of evaluating the effectiveness of the Healthy Kids Community Challenge (HKCC) on parental awareness of the HKCC program, parent support for child health behaviours and barriers to providing parental support. The survey is complemented by PHO's <u>Health Behaviours Of Students Survey</u> (Health BOSS), and a protocol for collecting direct measures of height and weight to calculate body mass index (available upon request, email hkccevaluation@oahpp.ca) that provide opportunities to link information from children to information from their parents.

Target Population

Health ChAMPS survey questions were developed for parents of children aged 10-12 years because this age group is within the target population of the HKCC program (0-12 years of age), and is the age of children targeted by PHO's Health BOSS because children of this age can reliably self-report on health surveys. Health ChAMPS is available in both official languages (French and English).

Survey Administration

The Health ChAMPS survey was designed to be administered online, but may also be administered in paper format.

Survey Validation

A number of measures of parental support that have been validated by previous research from Canada and elsewhere have been included. In addition, the survey has undergone a rigorous review process with parents of children in the target age group. The process included:

- (1) A **pre-test** that used one-on-one interviews with parents to determine the clarity, face validity, and the readability for every question in the Health ChAMPS survey.
- (2) A **pilot test** of the Health ChAMPS survey, in combination with Health BOSS, to determine the estimated time needed for parents to complete the survey, and identify potential issues with question responses.

Using Health ChAMPS

Although Health ChAMPS was designed to be used as above, it may be possible to adapt the Health ChAMPS survey for use in other target populations, and in other languages. The HKCC evaluation team at PHO would welcome any discussions/questions about using the survey, how the survey was developed, or how the survey might be adapted to local contexts.

- (3) Natural Sciences and Engineering Research Council of Canada (NSERC).
