

# Infection Prevention and Control (IPAC) in Child Care Centres

Published: May 2025

## Purpose

- To ensure consistency in IPAC practices across licensed child care centres throughout the province.
- To support child care operators in evaluating, and enhancing their current IPAC practices using provincial recommendations.
- To be used as a reference for the [Child Care Centre Cleaning and Disinfection Schedule](#).

## Instructions for Use

### When to use:

This checklist is intended to provide a summary of infection prevention and control (IPAC) recommendations in licensed child care centres.

It can be used for ongoing self-assessment by child care operators/licensees to review existing processes and identify gaps in practices that require correction or modification.

The notes sections can be used for observations or corrective actions.

There may be additional considerations left to the discretion of the Public Health Unit (PHU) and PHUs are encouraged to provide their own resources to supplement the recommendations in this checklist.

This checklist can be used in addition to, but does not replace, the advice, guidelines and recommendations, or other direction from provincial Ministries or local public health authorities.
