This fact sheet can be used by administrators and staff members in a range of congregate living settings to cohort (group) residents based on risk of COVID-19 or positive test results during an outbreak in the facility. It describes what personal protective equipment (PPE) to leave on and change when working within a cohort during a COVID-19 outbreak and when PPE is in short supply.

This is a more detailed document on cohorting intended for public health units to use when assisting congregate living settings in establishing and working in cohorts during a COVID-19 outbreak.
